Warning! Acknowledgment of Risks: I recognize that there are many inherent dangers in the use or presence of any saddle animal. Hazards may include, but are not limited to the following: uneven, unstable, wet, roads or ground, inclement weather, thunder lightning, wind, temperature changes. The presence of non-motorized and motorized vehicles, other horses and riders. Movement, noises, and contact with other objects which may frighten or cause the animal to rear, buck, bolt, run, or otherwise move unpredictably and with force. I realize that horses, ponies, or saddled animals can be unpredictable; No warranty of any kind, implied nor expressed, is being made as to the habits, dispositions, suitability, nature or physical condition of any animal. I acknowledge that approaching, saddling, unsaddling, mounting, dismounting, riding, my ability to control or direct an animal, equipment failure, and the speed at which I ride can pose a dangerous risk to my safety. There are certain risks normally involved in riding an animal, such as, but not limited to collisions, falls, and equipment failure. I also realize that participation in this activity can result in personal injury, accident, or death as well as loss of personal property.

Express Assumption Of Risk of Responsibility: In recognition of the risks involved in this activity, which I and any minor children for which I am responsible, will engage in. I/we confirm that I/we am/are physically and mentally capable of participating in this activity and using the equipment. I /we participate willingly and voluntarily. I assume full responsibility for personal injury, accident, or illness, including death, and any related expenses incurred. I assume responsibility for damages to or loss of my/our personal property.

Release: In consideration of services or property provided, I for myself, and any minor children for which I am parent, legal guardian, or otherwise responsible, any heirs, personal representatives, or assigns, do hereby release C-Arrow Stables, it's owners, representatives, directors, agents, employees, and volunteers, from all liability and waive any claim for damage arising from any cause whatsoever.

Items of Necessity

The child(ren) enrolled in the horse back riding instruction are required to wear long pants, closed toe shoes, preferably cowboy boots. Helmets are mandatory and must be a certified equestrian riding helmet if providing their own. Otherwise C-Arrow Stables will furnish the student with one prior to riding. It is suggested to wear sun screen and loose fitting clothing in order to keep cool. Riders should bring their own water bottle. Drink breaks will occur regularly during riding sessions. Small snacks are welcomed and recommended.

If your child(ren) are enrolled in an all day program please remember that riders must have their own snacks , lunch, and plenty to drink. Day campers may go swimming so a swim suit, towel, extra sun screen, pool shoes are also needed.
